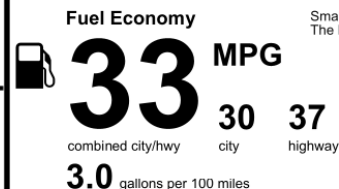

Gasoline Vehicle

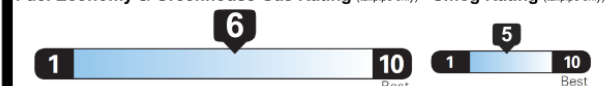
